1. GENERAL PROVISIONS

 - 2. The Consumer Rights Act of May 30, 2014 (Journal of Laws of 2014, item 827),
 - 3. The Civil Code Act of April 23, 1964 (Journal of Laws No. 16, item 93, as amended) and other relevant provisions of Polish law.

2. **DEFINITIONS**

- 1. CONTACT FORM a form available on the Website www.woloszyn.eu enabling the Customer to contact the Service Provider directly
- 2. REGULATIONS these Website regulations.
- 3. SERVICE PROVIDER Mieczysław Wołoszyn performing business activity under the name of Mieczysław Wołoszyn "Wołoszyn", registered office address: ul. Gersona 35, 03-307 Warsaw, address for service: ul. Gersona 35, 03-307 Warsaw, NIP: 5240013884, REGON: 010455678, entered into the Central Register and Information on Economic Activity, e-mail address: biuro@woloszyn.eu, tel. +48 22 811 04 47.
- 4. SERVICE RECIPIENT a natural person, legal person or an organizational unit without legal personality, which the law grants legal capacity to use the Electronic Service.
- 5. ELECTRONIC SERVICE a service provided electronically by the Service Provider to the Client via the Website.

3. TYPE AND SCOPE OF ELECTRONIC SERVICES

- 1. The Service Provider enables the use of Electronic Services via the Website, such as: 1. using the Contact Form,

- 2. The period for which the contract is concluded:

- 3. Technical requirements necessary for cooperation with the ICT system used by the Service Provider:

 - 3. Consideration of the complaint by the Service Provider takes place immediately, not later than within 14 days.
 - 4. The Service Provider's response to the complaint is sent to the Customer's e-mail address provided in the complaint or in another manner provided by the Customer.
